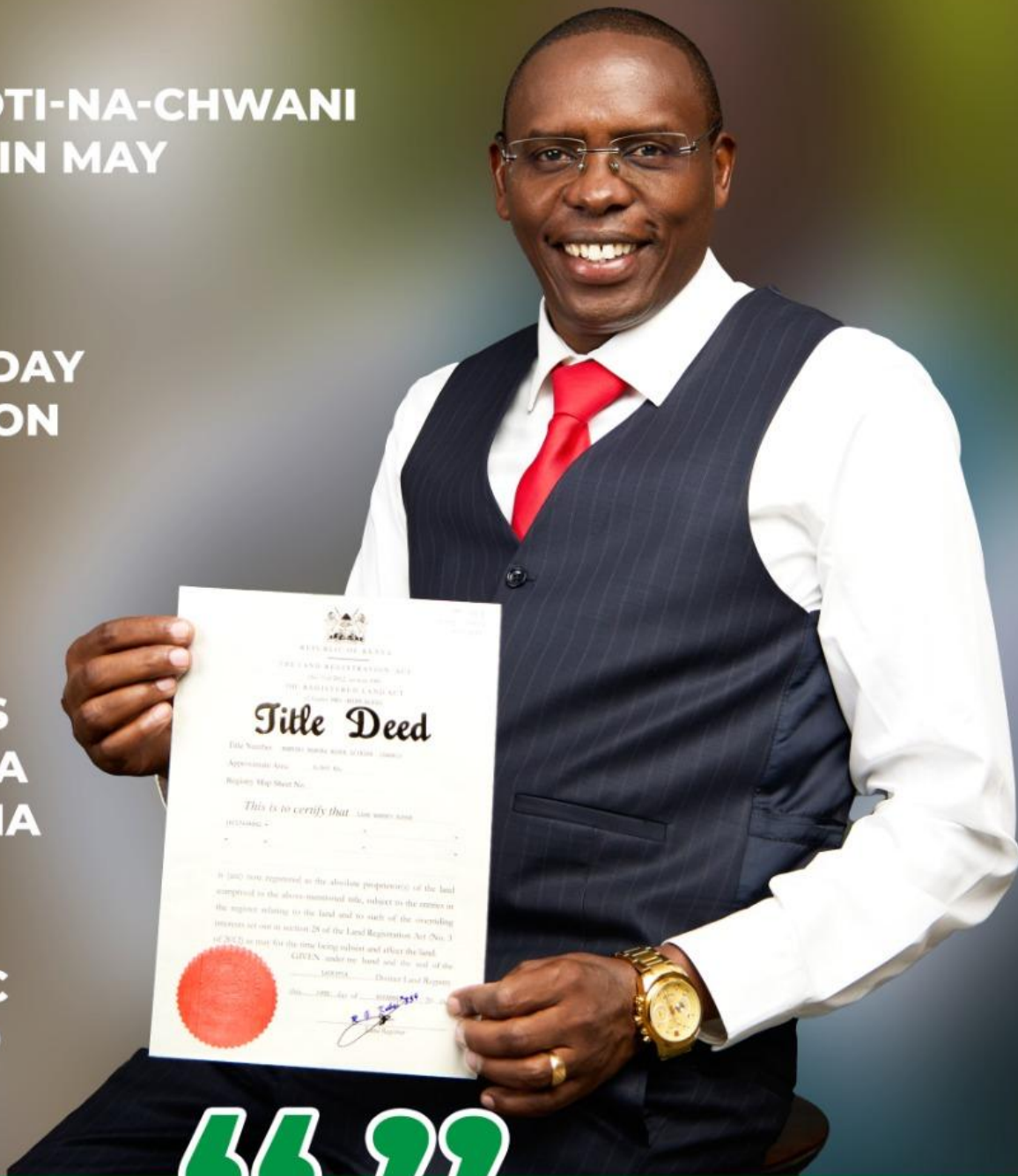

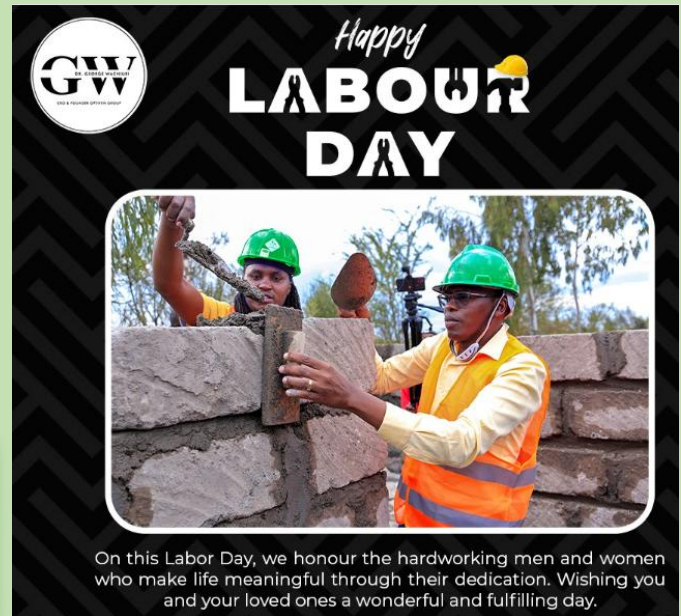

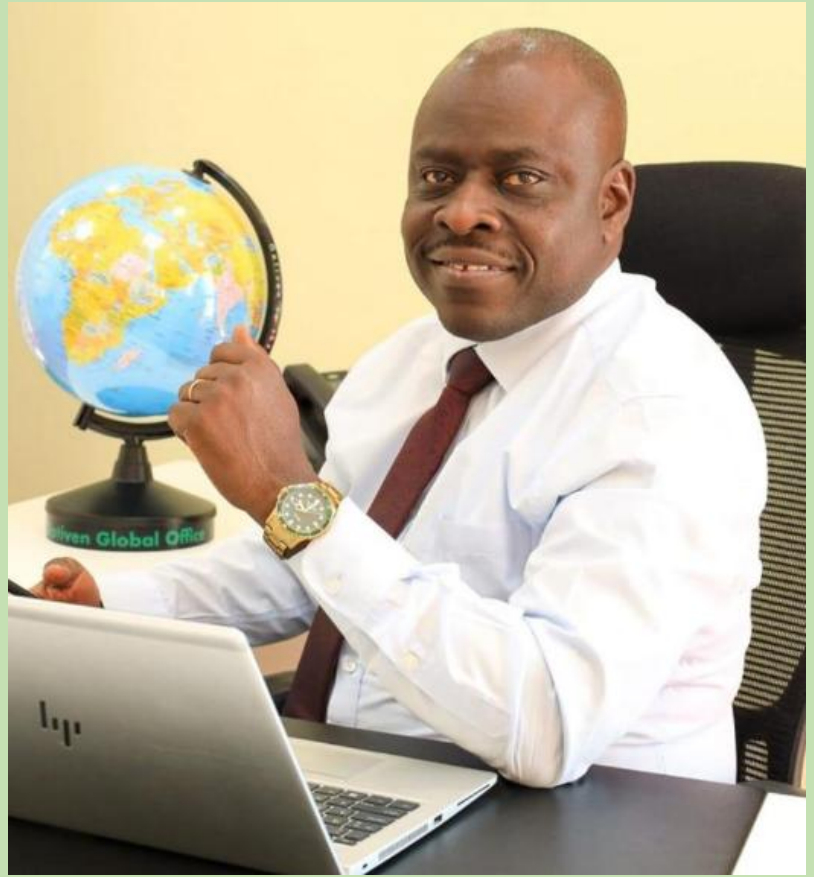
LEADERSHIP THOUGHTS ON 2030 STRATEGY | Perspectives of the GM Optiven

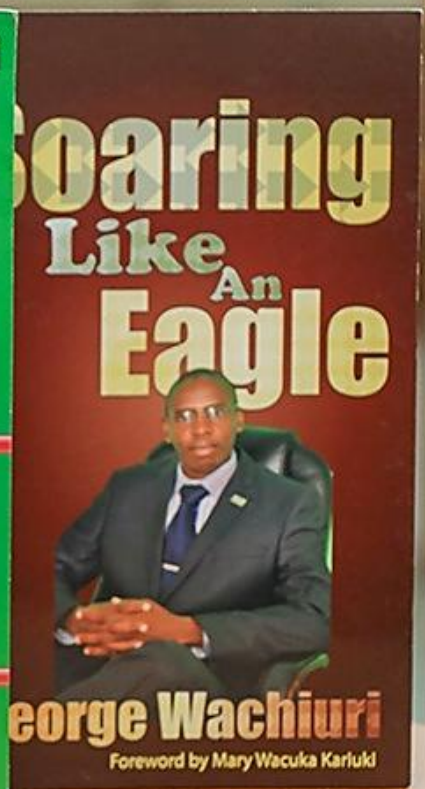
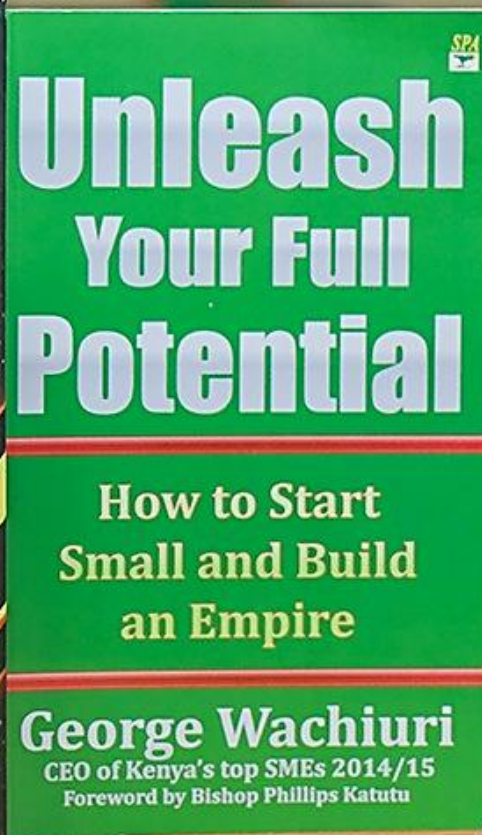
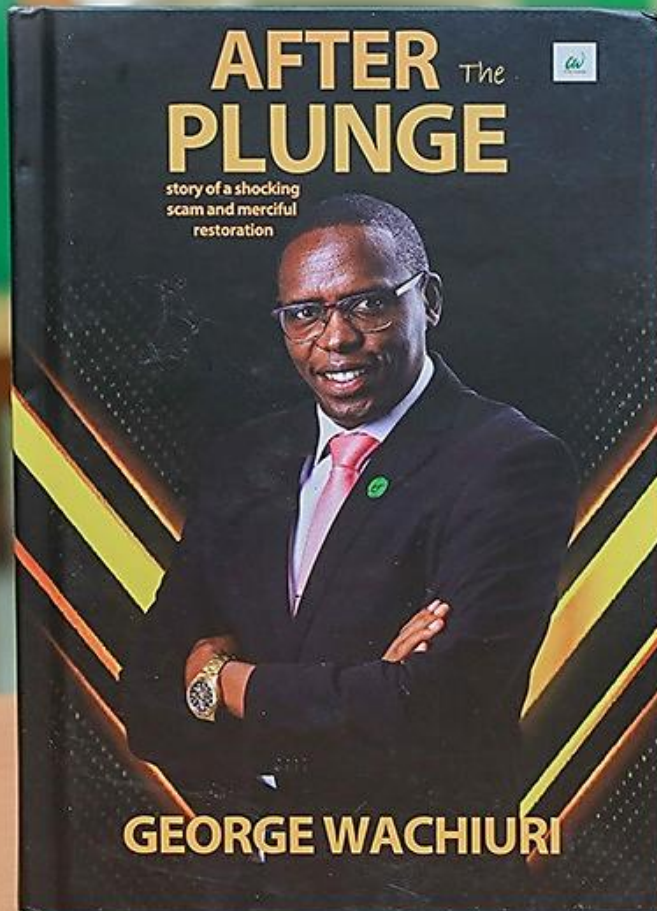
